Investment Objective

The Walden Midcap Fund seeks long-term capital growth through an actively managed portfolio of stocks of middle capitalization (“midcap”) companies.

Integrating ESG Research & Engagement

The Fund integrates environmental, social and governance (ESG) analysis into the investment selection and company engagement process. Among the issues on which Walden evaluates companies and pursues shareholder engagement are: product safety and desirability, workplace policies and practices, environmental impact, community impact and corporate governance and accountability.

The Fund actively promotes corporate accountability and positive change through company dialogue and shareholder resolutions, proxy voting, public policy initiatives, and educational outreach. In doing so, the Fund encourages companies to recognize that the sustainability of their profits is connected, in part, to how they treat workers, customers, communities and the natural environment as valuable, long-term assets.

Investment Strategy

The Fund invests at least 80% of its assets in domestic and foreign equity securities. “Assets” means net assets, plus the amount of borrowing for investment purposes. Shareholders will be given 60 days advance notice of any change to this policy. For these purposes, the Adviser defines midcap companies as those with market capitalizations within the range encompassed by the Russell Midcap® Index at the time of purchase. As of June 30, 2011, the market capitalization range of the Russell Midcap® Index was between \$1.4 billion and \$17.9 billion. The Fund also may invest in foreign securities.

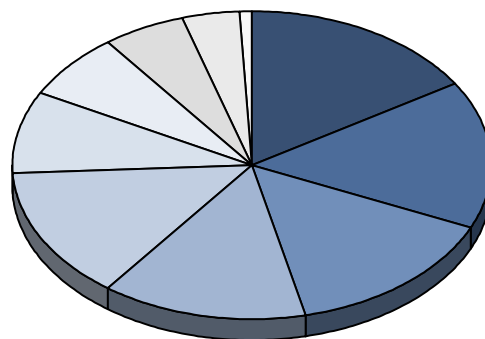

The Russell Midcap® Index represents approximately 27% of the total market capitalization of the Russell 1000 companies. Boston Trust and Walden currently manage \$5.4 billion in assets and employ a staff of approximately 50, including 22 investment professionals averaging 15 years with the firm and over 20 years in the industry.
